The scope of the project is to provide a turnkey solution for the delivery, lay, and commissioning of the Tusass Connect Domestic consisting of Tusass Connect Trunk (part of the trunk system in the Southern Route of the PACS) and Tusass Connect Domestic (branches to Qaqortoq, Aasiaat, and Ilulissat).

Eligibility
